

## 「亞洲卓越家傭保」及「亞洲卓越家務助理保」（統稱「計劃」）限時網上投保保費折扣優惠條款及細則

1. 推廣期由2026年5月18日至2026年6月30日（包括首尾兩日）（「推廣期」）。
2. 於推廣期內，客戶透過華僑銀行（香港）有限公司（「本行」）網站投保任何計劃，並輸入會員號碼（OCBCPRO）（「折扣碼」），可享相關計劃首年保費7折優惠（「優惠」）。
3. 該等計劃的保單一經簽發，恕不能取消且保費不獲退還。
4. 此優惠不可轉讓予其他人及兌換現金、退款或換取其他獎賞。

## Terms and Conditions of Limited-Time Online Application Premium Discount of “Asia Superior Helper Insurance” & “Asia Superior Housemaid Insurance” (collectively, the “Plans”)

1. The promotion period is from 18 May 2026 to 30 June 2026 (both dates inclusive) (the “Promotion Period”).
2. During the Promotion Period, customers who apply online for any of the Plans through the website of OCBC Bank (Hong Kong) Limited (the “Bank”) and enter the member code “OCBCPRO” (the “Promo Code”) can enjoy a 30% discount on the premium for the first policy year of the relevant Plan(s) (the “Offer”).
3. The Plans are non-cancellable, and no refund of premium is allowed once the policy of the relevant Plan(s) is/are issued.
4. This Offer is non-transferable and cannot be redeemed for cash, refunded, or exchanged for other offers or rewards.
5. This document does not provide any advice or recommendation of any insurance products. Customers should not rely solely on this document to make application decisions. Before applying for any insurance plan, customers should read carefully and fully understand the relevant terms and conditions of the relevant plan. Customers should also seek independent and professional advice before making any decision where necessary.

7. The Promo Code may only be used once for each application.
8. The Plans (namely, the “Asia Superior Helper Insurance” and “Asia Superior Housemaid Insurance”) are the insurance products of Asia Insurance Co., Ltd. (“Asia Insurance”) and not products of the Bank. The Plans are underwritten by Asia Insurance which is authorized and regulated by the Insurance Authority of the Hong Kong Special Administrative Region (“HKSAR”).
