

## 親愛的客戶:

感謝閣下支持華僑永亨信用卡。

## 華僑永亨信用卡 - 「高達0.8%現金回贈」計劃條款及細則:

- 1. 「高達0.8%現金回贈」只適用於已選擇現金回贈計劃或因華僑永亨飛行里程計劃之終止而轉換至現金回贈計劃之Infinite卡/World卡/白金卡客戶(包括聯營卡)。
- 2. 0.8%現金回贈比率只適用於所有本地食建及海外簽賬(網上交易及在海外之港幣交易除外)。
- **3.** 其他零售簽賬交易、每月汽車貸款供款金額及八達通自動增值金額只可獲0.5%現金回贈(「基本回贈比率」)。若新批核的汽車貸款 而首次於信用卡供款之誌賬日期為2017年1月4日或之後,每月供款可享之現金回贈上限為每筆HK\$50。

Prior to the Effective Date, you can choose either to convert all your remaining bonus points to Asia Miles or 0.5% Cash Rebate (i.e. every 200 bonus points can be converted to HK\$1 cash rebate, rounded up to the nearest cent). If you would like to convert your remaining bonus points to Asia Miles, please apply by submitting to us the "OCBC Wing Hang Travel Reward Scheme Asia Miles Conversion Form" ("Conversion Form") prior to the Effective Date. The Conversion Form can be downloaded from our website www.ocbcwhhk.com. On the other hand, application for conversion of 0.5% Cash Rebate can be made via our Customer Service Hotline at (852) 2543 2223. Any application for conversion of Asia Miles or 0.5% Cash Rebate will be treated as an application for converting all of the remaining bonus points in a single conversion. Upon completion of the conversion, your reward scheme will be automatically switched to "Up to 0.8% Cash Rebate" Scheme, and your subsequent spending reward will be credited to your credit card account on the next statement after transaction. You can enjoy up to 0.8% Cash Rebate on local food & beverage spending and overseas spending and up to 0.5% Cash Rebate on other retail transactions under this reward scheme.

Starting from the Effective Date, bonus point can no longer be used to convert to Asia Miles and all applications for conversion received by us will be deemed to be for the 0.5% Cash Rebate. Once the conversion of the remaining bonus points is completed, your reward scheme will then be switched to "Up to 0.8% Cash Rebate" Scheme automatically. - OCBC Wing Hang Credit Card Terms and Conditions for "Up to 0.8% Cash Rebate" Scheme

  1. "Up to 0.8% Cash Rebate" Scheme is only applicable to Infinite Card / World Card / Platinum Card Cardholder (including Co-branded Cardholder) who has opted for the Cash Rebate Scheme or switched to the Cash Rebate Scheme as a result of the termination of the OCBC Wing Hang Travel Reward Scheme.
- 2. 0.8% Cash Rebate ratio is only applicable to Local Food & Beverage spending or Overseas spending (excluding Internet transaction and Hong Kong dollar transaction made outside Hong Kong).
- 3. Other retail spending transactions, monthly car loan repayment amount and Octopus Automatic Add-Value reload amounts are eligible to 0.5% Cash Rebate ("Standard Rate"). If the first credit card billing for the newly approved car loan is posted on or after 4 January 2017, the cash rebate cap is HK\$50 per transaction.
- 4. Sun Life Financial premium payment made by the Sun Life Financial Co-branded card are eligible to "0.3% Cash Rebate" only.
- 5. Merchant category shall be determined at the sole and absolute discretion of merchant codes by Visa / Mastercard / UnionPay and the merchant acquiring bank.
- 6. The Cash Rebate will be shown on the next statement after transaction. No Cash Rebate will be granted if the total Cash Rebate in each monthly statement is less than HK\$1. The monthly Cash Rebate is capped at the Standard Rate of 5 times of the current permanent credit limit (not applicable to temporary credit limit and extra credit limit induced by credit balance)
- 7. The following transactions are not eligible for Cash Rebate: cash advances, cash installment plan transactions, Bill Payment transactions, Balance transfers, casino, all fees and charges, any counterfeit and unauthorized transactions, cancelled or refunded transactions.
- 8. All Cash Rebate rewards can only be used to offset retail spending / cash advances and cannot be converted into cash. The Cardholder's account must be valid and in good standing when the Cash Rebate is credited to the account. If the Cardholder cancels the account or the Bank under any circumstances cancels the account, the Bank shall forfeit the Cash Rebate accumulated in the Cardholder's account
