

## <u>華僑永亨信用卡費用及收費附錄表調整及</u> 持卡人協議修訂通知

由2016年11月1日起,下列的信用卡費用將調整如下:

項目	以港幣支付外幣簽賬的有關費用
現行	每筆以港幣支付外幣簽賬的交易^於折算後的交易金額的 <b>0.8%</b> (只限Visa 及 MasterCard)
修改後	每筆以港幣支付外幣簽賬的交易^於折算後的交易金額的 <b>1%</b> (只限Visa 及 MasterCard)

常下在外地或經外國網站消費時,有時候可選擇以港幣支付外幣簽 賬。此選項屬海外商戶的直接安排,而非由我們提供。閣下應於簽 賬前向該商戶查詢有關匯率及手續費的詳情,因為以港幣支付外幣 簽賬,所涉及的費用可能會較以外幣簽賬的手續費為高。

因應上述的調整,由2016年11月1日起,信用卡持卡 人協議條款7.22將修訂如下:

7.22 對於以其他信用卡組織所進行的以港幣支付外幣簽賬(不論交易在外地或經外國網站進行),我們收取之服務收費為有關折算後的交易金額的1%。我們有權不時對該服務收費作出修訂。

若貴客戶拒絕接受上述修訂之服務收費及/或合約條款,請於2016年10月31日前以書面通知本行,使本行可作適當的安排為貴客戶終止服務。否則貴客戶將被視作同意該修訂條款。

## Notice of Amendment of OCBC Wing Hang Credit Card Fee & Charge Schedule and Credit Card Cardholder Agreement

With effect from 1 November 2016, the below service fee will be changed as follows:

Type of Service	Fee relating to Settling Foreign Currency Transaction in Hong Kong Dollars
Current	<b>0.8%</b> on the converted transaction amount for every foreign currency transaction settled in Hong Kong dollars <sup>^</sup> (for Visa and MasterCard only)
New Fee	1% on the converted transaction amount for every foreign currency transaction settled in Hong Kong dollars^ (for Visa and MasterCard only)

<sup>^</sup> You may sometimes be offered the option to settle foreign currency transactions in Hong Kong dollars at the point of sale overseas or via foreign website. Such option is a direct arrangement offered by the overseas merchants and not us. In such cases, you are reminded to ask the merchants for the foreign currency exchange rates and the percentage of handling fees to be applied before the transactions are entered into since settling foreign currency transactions in Hong Kong dollars may involve a cost higher than the foreign currency transaction handling fee.

To cope with the above change, with effect from 1 November 2016, Clause 7.22 of Credit Card Cardholder Agreement will be amended to:

7.22 We charge a service fee at the rate of 1% on the relevant converted transaction amount for any other Card Association's Card Transaction (whether made overseas or via foreign website). We may revise such service fee from time to time.

If you do not agree to the above revised fee and charge and/or terms, you must notify us of your objection in writing before 31 October 2016 so that appropriate arrangements can be made to discontinue the service; otherwise you will be deemed to have consented to the revised terms
