

## **信用卡功能提升**

### **Visa payWave及萬事達卡感應式支付功能**

本行一直致力為客戶提供安全便捷的信用卡服務！由2018年10月起，本行將分批發出感應式支付功能之信用卡予Visa及萬事達信用卡客戶。屆時所有新發 / 補發 / 續期之Visa及萬事達卡將提升至備有Visa payWave或萬事達卡感應式付款功能，該卡卡面上會印有感應式付款功能標誌 。

閣下只需輕拍具有感應式付款功能的華僑永亨信用卡，於城中過千間設有Visa payWave或萬事達卡感應器的商戶，包括超級市場、便利店、餐廳及百貨公司簽賬，根據不同的商戶設定可進行高達HK\$1,000的感應式付款消費<sup>1</sup>而無需簽名。

如你不希望接受感應式付款功能之Visa及萬事達信用卡，請於2018年9月28日或之前以書面通知本行，使本行可作適當的安排。



## **Enhanced Credit Card Payment Function – Visa payWave and Mastercard Contactless Payment**

To bring you convenient, secure and fast credit card payment service and experience, starting from October 2018, the Bank will issue contactless credit card to cardholders by batches. All newly issued / replacement / renewal Visa card and Mastercard will have Visa payWave or Mastercard contactless payment function added. A contactless payment indicator  will be printed on your card indicating that card supports contactless payment function.

You can simply tap and pay with your OCBC Wing Hang Credit Card with built-in contactless payment function in thousands of stores, including supermarkets, convenience stores, restaurants and department stores, with Visa payWave or Mastercard contactless payment terminals. Depending on the setup of individual merchants, you can spend up to HK\$1,000<sup>1</sup> for each contactless payment transaction without signature.

If you do not wish to accept the Visa card or Mastercard with contactless payment function, you must notify us of your objection in writing before 28 September 2018 for further arrangement.
